- 5- That, the school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
- 6- That, the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation
- 7- That, the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bylaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bylaws, directions issued from time to time and the law of the land.
- 8- That, the school will ensure compliance of all statutory requirements like EPF, ESI and Labor Laws etc. with respect to the school and staff of the school.
